

2019 Football Season SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

DATES OF THE SWEEPSTAKES: The 2019 Football Season Sweepstakes (the “Sweepstakes”) is composed of three (3) separate entry periods, with one (1) drawing occurring per entry period. The date of each entry period is set forth in the ENTRY PERIODS section below. The timeframe for each entry period (the “Entry Period”) are as follows:

- First Entry Period: begins at 12:00 AM Pacific Time (“PT”) on December 1, 2019 and ends at 11:59 PM PT on December 31, 2019;
- Second Entry Period: begins at 12:00 AM Pacific Time (“PT”) on January 1, 2020 and ends at 11:59 PM PT on January 31, 2020;
- Third Entry Period: begins at 12:00 AM Pacific Time (“PT”) on February 1, 2020 and ends at 11:59 PM PT on February 29, 2020 (collectively, the Entry Periods are referred to as the “Sweepstakes Period”).

ELIGIBILITY: To enter the Sweepstakes, you must be a lawful permanent resident of the fifty (50) United States or the District of Columbia and at least the age of majority in your state of residence (nineteen (19) in Alabama, Nebraska, twenty-one (21) in Mississippi, and eighteen (18) in all other states) at the time of entry (the “Entrant”). Employees of CARD Corporation (the “Sponsor”) and each of its affiliated companies, parents, subsidiaries, and advertising and promotion agencies, including, but not limited to National Sweepstakes Company, LLC (the “Sweepstakes Administrator”), herein (collectively, the “Sweepstakes Entities”), and any service partners, as well as Card Corporation, The Bancorp Bank, Central Bank of Kansas City, Mastercard International Incorporated, and Visa U.S.A. Inc. (collectively, the “Releasees”) and their immediate families (i.e., parents, children, siblings, spouse) and members of their households (whether related or not) are ineligible to participate in this Sweepstakes. Sweepstakes is void outside of the fifty (50) United States, District of Columbia and where restricted or prohibited by law. By entering, Entrant agrees to be bound by these Official Rules, including all eligibility requirements and the decisions of the Sponsor, which are final and binding.

ENTRY PERIODS: For the purposes of this Sweepstakes, there will be one (1) drawing associated with each Entry Period. There will be one (1) grand prize winner (each a “Grand Prize Winner”) for each Entry Period. Each Entry Period will start and end on the dates and times shown in the Entry Period chart appearing below (the “Entry Period Chart”). All entries must be submitted during the time period shown in order to be included for that Entry Period’s drawing.

ALL NON-WINNING ELIGIBLE ENTRIES RECEIVED DURING PREVIOUS ENTRY PERIOD(S) WILL NOT CARRY OVER TO SUBSEQUENT ENTRY PERIOD DRAWINGS.

HOW TO ENTER: There are two (2) ways to receive entries into the Sweepstakes.

- 1. Direct Deposit Method of Entry:** Receive one (1) entry when one (1) qualifying direct deposit of \$500 or more from Entrant's employer or benefit provider posts to Entrant's CARD.com Prepaid Card account (the "Card") during an Entry Period. PLEASE NOTE: In order to qualify as a qualified entry, each direct deposit must post to the Card by the date(s) indicated in the Entry Period Chart to be eligible for the applicable Entry Period drawing. Direct deposits posted to the Card after 11:59 PM PT on February 29, 2020, will not be considered an entry.
- 2. Mail-in Method of Entry:** To receive entries into the Sweepstakes without having or using a Card. to make a direct deposit, on a plain 3" x 5" card, legibly print or type your name, age, complete address, city, state, zip code, home phone number (including area code), and email address (if any). Then, mail the 3" x 5" card in a postage-affixed sealed envelope to: "2019 Football Season Sweepstakes, P.O. Box 10490, Rochester, NY 14610. Mail-in entries must be postmarked and received by the dates indicated in the Entry Period Chart to be eligible for the applicable Entry Period drawing. No mechanically or programmatically reproduced entries are permitted. One (1) entry per envelope.

Limit of 1 entry per Entrant for each Entry Period, regardless of method of entry. There is a limit of one (1) Grand Prize per Entrant. Entrant may only use one (1) Card and one (1) email address to participate in this Sweepstakes. Entries received from any Entrant, email address, or Card in excess of the above-stated limitation will be void.

In the event of uncertainty as to the identity of an Entrant, the Entrant and Entrant's entries will be disqualified. Any Entrant who obtains more than the stated number of entries by using multiple/different identities, Cards, email addresses, accounts, and/or any other methods will void that Entrant's entries. No mechanically or programmatically reproduced entries are permitted. Sponsor will not verify receipt of entries for Entrants. All entries submitted become the sole property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, postage due or damaged entries, direct deposits or failed internet connections.

RANDOM DRAWINGS/ODDS OF WINNING:

Entry Period drawings: On or about the drawing dates outlined in the Entry Period Chart, one (1) Grand Prize Winner will be selected in a random drawing for each Entry Period conducted under the supervision of the Sweepstakes Administrator, an independent judging organization, whose decisions are based on their sole discretion and interpretation of these Official Rules, and are final and binding in all respects. All non-winning eligible entries from previous Entry Period drawings will not carry over to subsequent Entry Period drawings. Odds of winning depend upon the total number of entries received during the respective Entry Period.

PRIZES:

Grand Prizes: One (1) Grand Prize of an autographed football (each a "Grand Prize") will be awarded to each Grand Prize Winner per Entry Period. Total approximate retail value ("ARV") of each Grand Prize is \$50. The value of the Grand Prize will be dependent upon which player is chosen from a preselected list of players by the Grand Prize Winner to autograph the football. The approximate retail value does not reflect resale value of autographed football.

PRIZE RESTRICTIONS: Grand Prize cannot be substituted, assigned, transferred, or redeemed for cash except at Sponsor's sole discretion or as otherwise provided herein. Sponsor reserves the right to substitute Grand Prize with a prize of comparable or greater value if advertised Grand Prize should become unavailable. Grand Prize Winner is required to comply with any and all applicable federal, state and local laws, rules and regulations. The Grand Prize Winner is solely responsible for any taxes assessed with respect to the Grand Prize he/she has received, including but not limited to any and all federal, state and local taxes. No more than the one (1) Grand Prize per Entry Period as set forth in these Official Rules will be awarded.

Sponsor reserves the right to exclude from the Sweepstakes any potential Grand Prize Winner who is suspected of theft, fraud, or any criminal activity related to Sponsor or its affiliates. Entries associated with fraudulent Cards or other unauthorized use of Cards and entries associated with any similar fraudulent or inappropriate activities relating to any such Cards will be void and all such Entrants may be disqualified.

NOTIFICATION/PRIZE CLAIMS: Potential Grand Prize Winners will be contacted by phone or email within five (5) business days of the drawing date by the Sponsor or Sponsor representative ("Notification"). If a Grand Prize Winner cannot be contacted within five (5) business days of the first attempt to contact him/her or the Grand Prize Winner does not respond to the Notification within the date and time indicated within the Notification, then that Grand Prize Winner will be disqualified and an alternate Grand Prize Winner may be selected through a random drawing from among all remaining eligible entries received during the respective Entry Period.

Except where prohibited, each potential Grand Prize Winner must sign and return, within five (5) business days of receipt, an Affidavit of Eligibility/Liability/Publicity Release and an IRS W-9 Form (the "Paperwork") in order to claim the Grand Prize. Except where prohibited by law, Grand Prize Winner's entry and acceptance of the Grand Prize constitutes permission for the Sweepstakes Entities to use said Grand Prize Winner's name, photograph, likeness, statements, biographical information and voice on a worldwide basis, and in all forms of media, in perpetuity, without further compensation. If a potential Grand Prize Winner fails to return the Paperwork within five (5) business days of receipt of the Paperwork, or if an Entrant is found to be ineligible, or if he/she does not comply with the Official Rules, then the potential Grand Prize Winner in question will be disqualified and an alternate Grand Prize Winner may be selected through a random drawing by the Sponsor or Sponsor representative from the remaining non-winning entries received during the respective Entry Period. If the Notification or Grand Prize is returned as undeliverable, this will result in disqualification and an alternate Grand Prize Winner will be selected as outlined above. The Sponsor, or a third party acting on its behalf, must report the value of the Grand Prize to the Internal Revenue Service in the year the Grand Prize is received by the Grand Prize Winner and will be reported to the Grand Prize Winner and the Internal Revenue Service in the form of a Form 1099. In the event it is deemed during the verification process that the potential Grand Prize Winner has not provided a unique, personal, and valid Social Security number to Sponsor (or any party acting on its behalf) to report the tax liability associated with acceptance of his/her Grand Prize, the potential Grand Prize Winner will be disqualified and another potential Grand Prize Winner will be selected from among the remaining eligible entries received during the respective Entry Period. Valid social security numbers will be determined by IRS requirements.

Upon verification of status as a Grand Prize Winner, said Grand Prize Winner will be able to choose the player they would like to have autograph the football from a preselected list of players. Only the player name will be autographed on the football. The Grand Prize will be shipped to the Grand Prize Winner after Sponsor receives the autographed item from the selected player. Fulfillment of the Grand Prize will take approximately 4-8 weeks from Grand Prize Winner's selection of the player.

SWEEPSTAKES RULES OF PARTICIPATION: This Sweepstakes is subject to all applicable federal, state and local laws. By participating, Entrants agree to be bound by these Official Rules and the decisions of the Sponsor and waive any right to claim ambiguity in the Sweepstakes or these Official Rules. Sweepstakes Entities are not responsible for lost, late, misdirected, undeliverable, illegible, or incomplete entries, whether due to system errors or failures, faulty transmissions or other telecommunications malfunctions, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Sponsor may prohibit an Entrant from participating in the Sweepstakes or winning a Prize if, in its sole discretion, it determines that said Entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception, or other unfair playing practices (including the use of automated quick entry programs) or intending to annoy, abuse, threaten or harass any other Entrants, Sponsor, or Sweepstakes Entities. If for any reason this Sweepstakes is not able to be conducted as planned, including, but not limited to, by reason of infection by computer virus, bugs, tampering, unauthorized intervention, fraud or any other causes beyond the reasonable control of Sponsor or the Sweepstakes Administrator which corrupt or affect the administration, security, fairness, integrity or proper conduct of the promotion, then Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Sweepstakes and randomly draw the potential winners for the random drawing(s) in question from the applicable entries received up to the cancellation/suspension date. CAUTION: ANY ATTEMPT BY A PERSON TO DELIBERATELY DAMAGE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES MAY BE IN VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK REMEDIES AND DAMAGES (INCLUDING ATTORNEY'S FEES) FROM ANY SUCH PERSON TO THE FULLEST EXTENT OF THE LAW, INCLUDING CRIMINAL PROSECUTION.

NO LIABILITY: By entering, Entrants and Grand Prize Winners agree to comply with all Official Rules, as stated and agree to release, discharge, indemnify and hold harmless the Sponsor, its affiliates, and their respective agents, representatives, officers, directors, shareholders, and employees, including the aforementioned Releasees in the "ELIGIBILITY" section of these Official Rules, (now collectively defined as the "Releasees") from any claims, actions, injury, loss or damage of any kind, including, without limitation, personal injury or death, resulting, directly or indirectly, in whole or in part, from participating in this Sweepstakes or from the acceptance, possession, or use or misuse of the Grand Prize. This limitation of liability is a comprehensive limitation of liability that applies to all damages of any kind, including, without limitation, compensatory, direct, indirect, or consequential damages; loss of data, income or profit; loss of or damage to property; and claims of third parties. Entrants agree that Releasees have not made nor are in any manner responsible or liable for any warranty, representation, or guarantee, statutory, express or implied, including, without limitation, the implied warranties of merchantability, title, and fitness for a particular purpose, in fact or in law, relative to this Sweepstakes.

CHOICE OF LAW: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of participant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the substantive laws of the State of New York.
